- obtained minimum IELTS band 6.0 or TOEFL 550

*\*Note: Other recurring fees must be paid by the students.*
- Opportunity to be a part of our academic community\* (Teaching Assistance) *\*T&C apply*
- \*No additional monthly allowance will be given to the students.*

## WHAT ARE THE CRITERIA ?

### 1) FOR THE APPLICATION

- Academic excellence in first degree (GPA 3.0 and above, or equivalent);
- Fulfill the general entry requirements set by UPSI;
- Fulfill special entry requirements set by Faculty (if relevant)
- Obtain a minimum score of 6.0 for IELTS or 550 for TOEFL;
- Excellent past records both in academic and co-curricular activities
- Apply as a full time Master Degree by research mode.

### 2) TERMS & CONDITIONS DURING THE STUDY

- Must reside in Tanjong Malim, Perak, Malaysia (subject to current Covid-19 pandemic situation);
- Not allowed to leave the University without prior approval from the University;
- Complete the study within 3 semesters;
- Conduct a joint research with supervisor within the study period; and
- Publish two articles (Scopus/ERA/MyCite as First Author and supervisor as the corresponding author for graduation requirement.

# SPECIAL SCHEME FOR INTERNATIONAL MASTER STUDENT

## REMINDERS AND PENALTIES

A notice will be issued for unsatisfactory first research progress report.

Student will be terminated from the scheme for:

- i. unsatisfactory second research progress report, OR
- ii. failure to meet the publication requirement of two (2) indexed journal articles, OR
- iii. failure to complete the study within 3 years.

Student who has been terminated from the scheme will be given two (2) options as follows:

- i. If he/she continues continued to study – he/she shall pay for his/her own study fees for the following and remaining semesters and to pay the processing fee and tuition fee which were exempted; OR
- ii. If he/she discontinues to the study – he/she shall pay the processing fee and tuition fee that were exempted.
