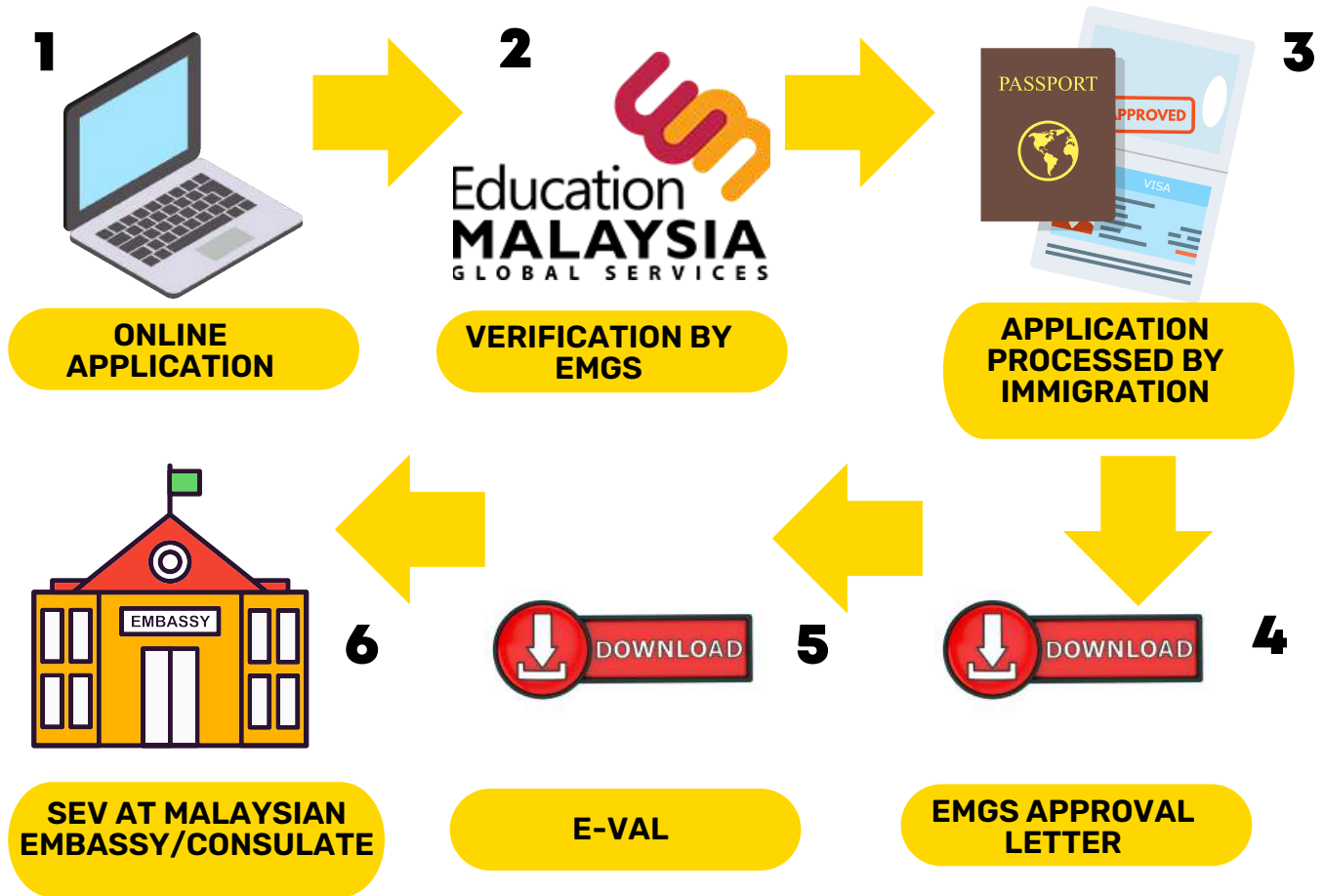

STEPS PRE-ARRIVAL STAGE FOR NEW STUDENTS



Living and being in Malaysia without a valid passport or permit is an offence under section 6(3) of the Immigration Act 1959/63 (Act 155)

Students entering with Social/Visit Pass may cause students to be asked to return to the home country



STEP 1



ONLINE APPLICATION

Students must apply for e-VAL through EMGS website visa.educationmalaysia.gov.my.

Document required to upload :

1. Passport Photo (White Background, 35mm x 45 mm, JPEG Format)
2. A valid offer letter and deferment letter (if any)
3. Passport Data Page
4. Academic record (Certificate and academic transcripts)
5. Health Declaration

STEP 2



VERIFICATION DOCUMENT BY EMGS

EMGS will verify the information and document uploaded in the EMGS system.

STEP 3



PROCESS APPLICATION BY IMMIGRATION DEPARTMENT

STEP 4



DOWNLOAD APPROVAL LETTER

Once the application reach 35% , student must download EMGS Approval Letter for online registration purpose.



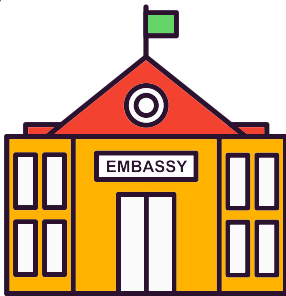
STEP 5



DOWNLOAD E-VAL FROM EMGS APPS OR WEBSITE

Application approved at 80%. Students must download e-VAL from EMGS Apps or website.

STEP 6



SINGLE ENTRY VISA (SEV)

Student must obtain Single Entry Visa (SEV) at the nearest Malaysian Embassy/ consulate in your home country with the e-VAL.

REMINDER!

- Students must **remain in their country** while the Calling Visa Application is processed.
- Calling Visa (VDR) for new student applications will be processed and completed **within 2/3 months**.

APPLICANTS MUST BE OUTSIDE OF MALAYSIA WHEN APPLYING FOR A STUDENT PASS AND ARE ONLY ALLOWED TO ENTER THIS COUNTRY UPON RECEIVING APPROVAL FROM THE MALAYSIAN IMMIGRATION.

PLEASE ENSURE YOU HAVE RECEIVED VISA APPROVAL LETTER (EVAL) THROUGH EDUCATION MALAYSIA GLOBAL SERVICE (EMGS) BEFORE ENTERING MALAYSIA.
